Consideration of Natural Gas Pipeline ROW Request/Wildcat Midstream Part./Pool 5, Tracts 10 & 58 - By motion of Commissioner Dupuy, seconded by Commissioner Owens, the Commission unanimously approved the natural gas pipeline ROW request by Wildcat Midstream Partnership at Pool 5, Tracts 10 & 58 at a cost of \$450.00 per rod for 356 rods for a term of 25 years with the option to renew for an additional 25 year term. Authority to Initiate Process for Timber Harvest/Ft. Buhlow Recreation Area - By motion of Commissioner Dupuy, seconded by Commissioner Owens, and unanimously approved, staff was authorized to initiate the timber harvest process at the Ft. Buhlow Recreation Area.
